# ANNUAL PHYSICAL EXAMINATION OF NON-TEACHING PERSONNEL IN THE DIVISION

- 1. Pursuant to Civil Service Commission Memorandum Circular No. 17, s. 1989 and DepEd Order no.14, s.2020 entitled Guidelines on the Required Health Standards in Basic Education Offices and Schools, this office shall ensure that all non-teaching personnel shall undergo annual physical examination with the provisions of RA 11223 or the Universal Health Care Act and its Implementing Rules and Regulations. The conduct of the physical examination shall be in accordance with precautionary and protective measures in light of the COVID-19 health emergency.
- 2. The annual medical and dental examination shall be conducted to ensure that all employees are fit to perform their assigned duties and functions to render efficient and quality public service to all its clientele and to promote the health, safety and well-being of all in the midst of COVID-19 Pandemic.
- 3. Listed below are the different diagnostic examinations required by the Department:

a.Complete Blood Count

b.Complete Blood Chemistry including Fasting Blood Sugar, Liver Enzyme Test(SGPT and SGOT) and Kidney Profile (Creatinine and BUN), Blood Uric Acid, Lipid Profile (LDL, HDL, Total Cholesterol and Triglycerides) c.Urinalysis

d.Chest X-ray (PA view) with official reading with the exclusion of pregnant employees.
