CONDUCT OF ONLINE ENCODING OF SCHOOL'S WINS STATUS AND SELF RATING USING THE THREE STAR APPROACH AND RECOGNITION SYSTEM IN ALL PUBLIC ELEMENTARY AND SECONDARY AND INTEGRATED SCHOOLS

1. The daily practice of good health and sanitation habits form the cornerstone in keeping oneself strong and healthy especially in the midst of COVID-19 Pandemic. Practice of frequent handwashing, proper cough etiquette, proper wearing and disposal of personal protective equipment and physical distancing are some of the critical steps in the prevention and spread of COVID-19 Virus and its variant strains.

In connection with this, the Department of Education under the Bureau of Learners Support System is committed in teaching its lifelong learners about good hygiene and sanitation practices in schools and develop good health habits that they eventually can do on their own. 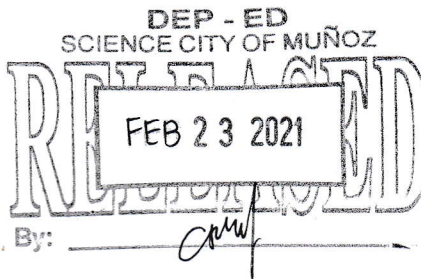
