REGISTRATION OF QUALIFIED VOTERS TO THE 2022 NATIONAL AND LOCAL ELECTIONS

- 1. Pursuant to OUA Memo 00-0421-0105 dated April 20, 2021 and Republic Act (RA) No. 8189 otherwise known as the *Voter's Registration Act of 1996*, the Schools Division Office encourages all eligible learners and young people to exercise their rights and actively participate in the National and Local Elections on May 9, 2022.
- 2. In line with this, all Supreme Student Government Presidents and Advisers are requested to come up with a voter's registration campaign that will inspire qualified learners to register and participate in the elections.
- 3. Attached are the qualifications/requirements for voter's registration as stated in Section 9 of RA 8189 and Section 5 of COMELEC Resolution No. 10549.
- 4. All eligible learners are encouraged to register at the nearest Commission on Elections (COMELEC) Office while strictly observing the existing Inter-Agency Task Force (IATF) guidelines in their respective communities.
- 5. Activity completion reports (School Memorandum, activity proposal, narrative report and documentation) of the said campaign shall be submitted to the School Governance and Operations Division-Youth Formation Coordinator.

Qualifications/requirements for voter's registration per Section 9 of RA No. 8189 and Section 5 of COMELEC Resolution No. 10549

- Any Filipino citizen who is not yet a registered voter, may apply for registration, provided he/she is at least eighteen (18) years of age on or before May 9, 2022 National and Local Elections;
- A resident of the Philippines for at least one (1) year and in a place wherein he/she proposes to vote, for at least six (6) months immediately preceding the May 9, 2022 National and Local Elections; and
- · Not otherwise disqualified by law.
- Any person who has not reached the required voting age or period of residence on the day of registration but will possess such qualifications on or before May 9, 2022 National and Local Elections, may register as a voter. However, the reception of their applications shall commence only on May 10, 2021 (at least one year prior to election day)
