- 2. Applicants should meet the following minimum qualifications as specified in DepEd Order No. 66, s. 2007 (Qualification Standards for the Position Administrative Aide VI), to wit:
  - 2.1 Education: Completion of two years studies in College
  - 2.2 Experience: None Required
  - 2.3 Training: None Required
  - 2.4 Eligibility: Career Service (Sub Professional/First Level Eligibility)
- 3. Applicants shall submit their pertinent documents for initial evaluation on or before June 23, 2021 at the Records Section.
- 4. All documents submitted for evaluation must be certified photocopies of the original documents. Original documents must be presented during the evaluation and deliberation process for verification purposes.
- 5. In consonance with the Merit Selection Plan of the Department, applicants who shall be included in the Top 5 and who obtained the required number of points shall undergo deep selection process and in-depth performance validation by the Human Resource Management Personnel Selection Board. The results of the deep selection and validation shall be the basis for recommendation to the appointing authority.
