Consultation will be entertained from 2:00 PM to 4:00 PM, Tuesday and Thursday only until December 31,2021, with electronic prescriptions issued for the maintenance and over the counter medications in compliance with the guidelines released by the Food and Drug Administration (FDA). All messages and transmitted information will be properly documented and all personal data will be handled in accordance with the Data Privacy Act.
