CONDUCT OF BASELINE ONLINE ENCODING OF SCHOOL'S WINS STATUS AND SELF- RATING USING THE THREE STAR APPROACH AND RECOGNITION SYSTEM IN ALL PUBLIC ELEMENTARY AND SECONDARY AND INTEGRATED SCHOOLS FOR SY 2021-2022

1. The daily practice of good health and sanitation habits form the cornerstone in keeping oneself strong and healthy especially in the midst of COVID-19 Pandemic. Practice of frequent handwashing, proper cough etiquette, proper wearing and disposal of personal protective equipment and physical distancing are some of the critical steps in the prevention and spread of COVID-19 Virus.
2. In connection with this, the Department of Education under the Bureau of Learners Support System is committed in teaching its lifelong learners about good hygiene and sanitation practices in schools and develop good health habits that they eventually can do on their own. Furthermore, the creation of the WinS Program in Schools as being stipulated in DepEd Order No.10 s.2016 under the Oplan Kalusugan Ok sa Deped Program is designed to achieve learning, healthy outcomes, and improve school attendance among learners through a comprehensive, sustainable and scalable school-based water, hygiene, sanitation, deworming and menstrual management.
