- 1. Anent to Joint Memorandum Circular No. 01, s.2021 with subject Operational Guidelines on the Implementation of Limited Face to Face Learning Modality and DepEd Order No. 85, s. 2021 entitled Preparation for the Implementation of the Expanded Phase of Face to Face Classes, all eligible learners, teaching and non-teaching personnel in Public and Private Schools including SUCs are highly encouraged to be vaccinated against the COVID-19 Virus.
- 2. Pediatric population ages 12 to 17 years old were included as eligible vaccinees under the A3 and A6 category under the National Vaccination Program against COVID-19. The vaccination program aims to provide an added layer of protection against the virus aside from the strict implementation of the required health standards and protocols in DepEd Offices and Schools in preparation for the mass limited face to face classes come this January 2022. All Public and Private Schools including SUCs are advise to conduct advocacy activities on demand generation for COVID-19 Vaccination.
- 3. In line with this, all Schools Public and Private COVID-19 Focal Person/ Vaccine Coordinator in the Schools Division of Science City of Munoz are hereby advised to encode their teaching and non-teaching personnel and
