

LIGTAS NA BALIK ESKWELA, TARA NA! DEPED REGION III SPECIAL LIVE COVERAGE ON THE MASS EXPANSION OF LIMITED FACE TO FACE CLASSES

To: Schools Division Superintendents

School Information Coordinators

- 1. In line with the mass implementation of limited face to face classes in Region III on January 10, 2022, the Public Affairs Unit shall conduct the Ligtas na Balik Eskwela, Tara Na! DepEd Region III Special Live Coverage on the Mass Expansion of Limited Face to Face Classes from 8:00 a.m. until 10:30 a.m. via Facebook Live.
- 2. The said live coverage shall highlight the actual reopening of schools in the region and the preparations undertaken by all stakeholders to ensure the safe return of students in the said schools. To facilitate this coverage, each Schools Division Office (except Bulacan, CSJDM, Malolos City, and Meycauayan City) are requested to create a team composed of a Division Broadcaster, Cameraman, and Production Assistant. The Division Information Technology Officer or any ICT Coordinator may be tapped to assist in the live coverage.
- 3. The five-minute live report shall contain information regarding the total number of schools participating in the implementation of face to face classes, total number of students who have physically attended on the first day, and stakeholder involvement in the preparations for the school reopening.
- 4. The Program Flow and Sample Script are provided as attachments for reference.
- 5. To maximize the reach and audience engagement for the said program, all SDOs and schools are requested to share the livestream on their official Facebook pages on January 10, 2022.
- 6. To ensure the smooth flow of the said live program, there will be a technical run on January 6, 2022 at 1:00 p.m.
- 7. The SDO Live Coverage Team are advised to strictly observe health protocols and standards such as wearing of face masks during the conduct of the live reporting in the school.

### SAMPLE SCRIPT/FLOW OF SDO LIVE REPORT

#### REPORTER:

Maraming salamat Mam Michelle. Andito ako ngayon sa (name of school/SDO) upang ihatid ang huling kaganapan kaugnay sa muling pagbubukas ng mga paaralan dito sa buong Schools Division ng (SDO).

Nakita natin kanina kung paano unti-unting dumating sa ating paaralan ang mga mag-aaral at kung papaano ipinatupad ang mga health protocols upang masiguro ang kaligtasan ng mga mag-aaral at mga guro.

Sa ngayon, ayon sa ating tala, mayroon po tayong (number) mga mag-aaral na binigyan ng consent ng kanilang mga magulang upang makilahok sa in-school education.
