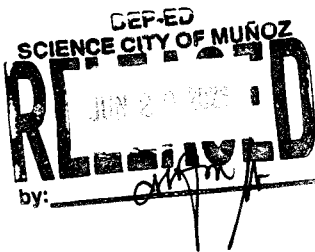

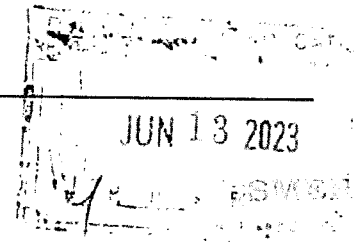

The Philippine Elementary School Principals Association (PESPA) Region III Chapter will hold its 12th Philippine Elementary School Principals Development Program with the theme **"Upskilling School Managers on the Realization of DepEd's MATATAG Agenda- Bansang Makabata, Batang Makabansa: A Tool in Enhancing the Culture of Holistic Learning, Patriotism and the Virtue of Love for Children"** from October 17-19, 2023 at Vigan Convention Center, Vigan City, Ilocos Sur.
