**SCHOOLS DIVISION TRAINING-WORKSHOP IN CAMPUS JOURNALISM
FOR SCHOOL PAPER ADVISERS (SPAs)**

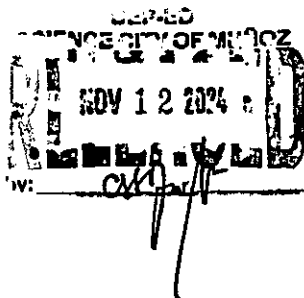

1. Republic Act 7079, the Campus Journalism Act of 1991, promotes free speech and press freedom in schools. It encourages campus journalism to develop critical thinking and ethical values among learners. The implementation of the act is guided by DepEd Order No. 94 s.1 1992, which provides necessary rules and regulations.
2. In view of the above and in preparation for the upcoming division, regional, and national schools press conferences, this Office, through the Curriculum Implementation Division, announces the conduct of **Schools Division Training-Workshop in Campus Journalism for School Paper Advisers (SPAs)** on **November 28 to 29, 2024**, at the **SDO Teachers' Hall**.
3. The said training-workshop aims to:
 - a. equip SPAs with advanced skills in various forms of journalism to ensure quality student outputs;
 - b. emphasize the importance of journalism in fostering social responsibility, environmental awareness, and ethical media practices;
 - c. promote collaboration and sharing of effective coaching strategies among SPAs and trainers to better support student-journalists;
 - d. enhance the ability of SPAs to mentor students in various categories, improving their skills for higher competitions; and
 - e. strengthen participants' capabilities in managing student publications and guiding campus journalism programs toward sustained excellence.
4. Participants are expected to bring laptops, extension cords, and pocket WiFi devices.
5. Only the official participants listed in the Memorandum are permitted to attend, and proxies are strictly prohibited.

Food and travel expenses arising from the participation of school paper advisers shall be covered by their respective school MOOE and other local fund sources subject to standard accounting and auditing rules and regulations. Meanwhile, food of the technical working group, resource speakers, and honoraria of resource speakers shall be charged against the Special Education Fund (SEF).
7. This issuance shall serve as the official **Authority to Travel** of the participants involved in the activity.
